ANNOUNCEMENT

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of the Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the laws of Hong Kong).

The board (“**Board**”) of directors (“**Directors**”) of SIM Technology Group Limited (“**Company**”, together with its subsidiaries, “**Group**”) hereby announces that the unaudited monthly revenue of the Group was as follows:

1. Comparison of revenue with last month

Due to the adjustments by the Group’s customers in respect of the delivery time of their purchase orders, both the Group’s deliveries and revenue from core business in October 2023 increased significantly as compared to those in September 2023. The revenue from non-core business predominantly comprised of rental income. The revenue from non-core business in October 2023 was roughly the same as that in September 2023.

2. Comparison of revenue from core business with same month last year

The Group's deliveries and revenue from core business in October 2023 were roughly the same as those in the same period last year.

3. Comparison of total unaudited revenue of the Group for the ten months ended 31 October 2023 with same period last year

Due to the adjustments by the Group's customers in respect of the delivery time of their purchase orders, the total unaudited revenue of the Group for the ten months ended 31 October 2023 decreased as compared with that in the same period last year.

The core business of the Group comprises the ODM (original design manufacturer) of handsets and IOT terminals business and the non-core business of the Group comprises properties management.
